### **Services offered by all chapters of The Arc:**

- **Information and referral** – helping people to connect to their communities
- **Technical assistance** – helping people to understand and navigate government programs such as TennCare, Social Security, Medicaid Waivers, etc.
- **Public awareness** – helping the community understand the needs and capabilities of people with intellectual and developmental disabilities
- **Individual advocacy** – helping people who are experiencing specific problems that require more intensive coordination

### **Additional services, supports and activities of The Arc Tennessee:**

- **Public policy** – working with government officials at the state and national level to promote best practices in law and policy for people with IDD and their families
- **Systems advocacy** – engaging collaborative partners to improve systems of supports and services for people with IDD and their families through program analysis and other work
- **Education and training** – conducting workshops on topics important to people with IDD and their families such as alternatives to conservatorship, future planning, secondary transition, special education, self-advocacy, etc.
- **Local chapter development** – supporting small groups to become local chapters of The Arc through technical assistance
